



FINANCIAL OBLIGATION/REFUND POLICY

As a parent, I have been made aware of the financial obligation that comes along with registering with Arizona Arsenal Soccer Club. I understand that if I fail to fulfill the financial obligations set forth herein, then the Club reserves the right to pull that player's pass, and that player will be placed in bad standing with the appropriate governing bodies until such time that the financial obligation is satisfied. During this time, the affected player will not be allowed to participate in practices, games, events or other Club activities.

If a player elects to leave a team for any reason at any point in time during the season, there will be no refund of the training fees, team fees, or uniform costs. There will be no waiver of any outstanding or future financial obligation due to AASC or the team for the entire season. A player may not leave Arizona Arsenal Soccer Club to join another soccer club until all outstanding financial obligations to AASC and the player's team had been paid in full. If a player attempts to join another soccer club prior to paying all such amounts, AASC will begin proceedings to place this player in financial bad standing with AYSA. If there is an extenuating circumstance such as a season ending injury (**during which a documented time period of 3 months or longer,**) please contact the Club Registrar, the Team Manager and Coach. Requests should begin with an e-mail to the Club Registrar.

RELEASE OF LIABILITY FOR MINOR PARTICIPANTS – READ BEFORE SIGNING

IN CONSIDERATION OF my child/ward _____ being allowed to participate in any way in the Arizona Arsenal Soccer Club and its related events and activities, the undersigned acknowledges, appreciates, and agrees that:

- The risk of injury to my child from the activities involved in these programs is significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist, and,
- 1. FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown and assume full responsibility for my child's participation; and,
- 2. I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child's readiness for participation and/or in the program itself, I will remove my child from the participation and bring such attention of the nearest official immediately; and,
- 3. I myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS Arizona Arsenal Soccer Club, its directors, officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property incident to my child's involvement or participation in these programs, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
- 4. I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releasees from any and all liabilities incident to my involvement or participation in these programs, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law.
- 5. I, the parent/guardian, assert that I have explained to my child/ward: the risks of the activity, his/her responsibilities for adhering to the rules and regulations, and that my child/ward understands this agreement.

I, FOR MYSELF, MY SPOUSE, AND CHILD/WARD, HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT WE HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
